

(57) Abstract: For the classification of images, a classification measure is computed by registering a set of images to a reference image and performing linear discriminant analysis on the set of images using a conditioned within-class scatter matrix. The classification measure may be used for classifying images, as well as for visualising between-class differences for two or more classes of images.
